This warranty does not cover abuse, incorrect application or installation, neglect and after sale damage. Our goods come with guarantees that cannot be excluded under the Australia Consumer Law (ACL). You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. THE PROVISIONS OF THIS LIMITED WARRANTY SHALL NOT APPLY OR EXTEND TO ANY PRODUCTS THAT HAVE BEEN SUBJECT TO:

ABUSE, NEGLIGENCE OR BREAKAGE DUE TO IMPROPER HANDLING, OPERATION AND MAINTENANCE INCLUDING BUT NOT LIMITED TO; IMPROPER INSTALLATION, BATTERIES INSTALLED WITH OTHER MAKES AND/OR MODELS IN THE SAME STRING, OVER-DISCHARGING THE BATTERIES, IMPROPERLY SIZED BATTERIES FOR THE APPLICATION, EXPOSURE TO EXCESSIVE HEAT OR COLD TEMPERATURES, BULGING BATTERIES, FROZEN BATTERIES, FIRE, EXPLOSIONS, IMPROPERLY SIZED CHARGING SYSTEMS, IMPROPER CHARGING (UNDERCHARGING, OVERCHARGING), USE OF THE BATTERY IN AN UNCHARGED CONDITION, DISCHARGED BATTERIES, SHIPPING DAMAGE, LOOSE CABLE CONNECTIONS, RUSTED OR CORRODED HARDWARE, IMPROPER STORAGE, IMPROPER HANDLING, BATTERIES THAT ARE DROPPED, BATTERY MODIFICATIONS, PRESSURE RELIEF VALVES THAT HAVE BEEN TAMPERED WITH OR REMOVED, CRACKED COVERS AND CASES, BATTERIES DAMAGED FROM ELECTRICAL EQUIPMENT, IF THE MANUFACTURING AND/OR FINISHING DATE CODES HAVE BEEN DESTROYED OR TAMPERED WITH, OR IF THE BATTERIES HAVE NOT BEEN USED, OPERATED, AND/OR MAINTAINED IN ACCORDANCE WITH DELTEC BATTERIES OPERATING AND MAINTENANCE INSTRUCTIONS.
